### PREAMBLE

The [Group Name] Group is entered into the **Programme** consisting of a set of **CGS Contracts** and associated services rendered by the **Insurers** to the **CGS Insureds**.

In the framework of the **Programme**, the **Group** benefits from group conditions detailed in a **Master Agreement**. The clauses of the **Master Agreement** which You benefit from as member of the **Programme** [and as **Head of Insured Group/ Support Insured**] are detailed hereafter (the "**Group Clauses**").

It is expressly agreed that, as long as your **Contract** is eligible to the **Master Agreement**, **Group Clauses** detailed hereafter (i) complete your **Contract** and/or (ii) supersedes your **Contract** clauses relating to the same object. Should You lose the benefit of the **Master Agreement**, and after our notification of such event to You, the **Group Clauses** will not be applicable any longer and original clauses and conditions of your **Contract** will be exclusively applicable.

For the application of the **Group Clauses**, it is hereby expressly agreed that the currency used will be [currency of the Programme] ("the *Currency Of The Programme*") defined in the **Contract List**. The exchange rate between the currency of your **Contract** and the *Currency Of The Programme* determined for the calculation of the **Group Clauses** is agreed with the **Head of Insured Group** at the beginning of each *insurance period* for such *insurance period*. In the event that at the time of application of a **Group Clause** the actual exchange rate of the currency of your **Contract** is at least 50% above or below the exchange rate agreed with the **Head of Insured Group**, We shall apply the monthly rate defined by your **Contract** as stated in the article Currency of the Special Terms instead. In this event, for the calculation of a **Group Clause** that:

- triggers payment of an indemnity, the monthly rate will be the rate of the month prior to the expiration of the *waiting period* of this claim.
